

Private and Public Health Care and Social Assistance Establishments




Healthcare and social assistance continues to have the highest employment of any industry in the Commonwealth, according to QCEW annual averages. Registered nurses and medical assistants continue to be among the most in demand occupations throughout Virginia. The industry is responsible for 13.1 percent of total employment in Virginia, with an annual average of 488,927 jobs in 2020. The industry also accounts for 11.1 percent of total wages at \$27.1 billion. The number of establishments is at a record high following several years of decreasing. Wages have risen steadily over the last five years with average weekly wages just below the statewide average at \$1,064 per week. Unlike many industries, employment in healthcare and social assistance is relatively spread out. While the more densely populated areas of the Commonwealth such as Northern Virginia, the Capital Region, and Hampton Roads tend to see higher employment within the industry, the concentration is approximately equal. General medical and surgical hospitals continues to be the largest sub-sector, accounting for 24.4 percent of all healthcare employment.







Professional, Scientific and Technical Services




Professional, scientific and technical services has the second highest average annual employment in the Commonwealth. QCEW annual averages estimate that this industry accounted for 446,738 jobs in 2020, or 11.9 percent of total employment in Virginia. Employment within this industry has grown 10.0 percent since 2015. Despite being the industry with the second highest employment, professional, scientific and technical services accounts for more than \$50.7 billion in total wages. This is approximately 20.8 percent of total wages in the Commonwealth, and almost double the wages of the top industry. With average weekly wages at \$2,184, the industry remains well above the statewide average weekly wage of \$1,253 per week. Computer systems design and related services drives much of the positive trend in employment and wages within the industry. This sub-sector accounts for roughly 38.1 percent of all employment in this industry, and has added more than 16,700 jobs over the last five years. The management consulting services sub-sector has also contributed to the growth of this industry. Employment within this sub-sector has increased by 18.8 percent during the last five years.





Retail Trade




Despite large employment losses over the last five years in sub-sectors like department stores and clothing stores, the retail trade industry has remained the third largest in terms of annual employment. Retail trade accounted for 10.4 percent of statewide employment in 2020 or 390,953 jobs. Despite the high employment numbers, the retail trade industry accounts for only 5.4 percent of total wages in the Commonwealth. Average weekly wages in the industry have risen to \$650 per week, approximately half of the statewide average of \$1,253. Over the past five years, the number of retail trade establishments has continued to trend downward. In 2020, establishments totaled 25,467, down 4.3 percent since 2015. The decrease in establishments in part explains the 7.9 percent decrease in employment over the last five years, which is a loss of 33,482 jobs across the Commonwealth. Grocery stores are one sub-sector that has seen impressive growth in employment. Since 2015, grocery stores have added over 6,000 jobs, an increase of 8.4 percent. Employment growth in some specific sub-sectors of the retail trade industry has helped to offset the losses of traditional department stores and clothing stores.





Accommodation and Food Services




Accommodation and food services remains fourth in average employment at 279,213 jobs. This is despite a 16.2 percent decrease in employment over the last five years. At \$404 per week, the average weekly wage for this industry is about one-third the statewide average. Accommodation and food services has the lowest average weekly wages out of the five top industries, and they account for just 2.4 percent of Virginia's total wages at just over \$5.8 billion. The full service and limited service restaurants sub-sectors alone are responsible for 78.0 percent of the total industry employment. These sub-sectors also have some of the lowest average weekly wages of all the sub-sectors in the industry at \$421 and \$333 per week respectively. Though wages have continued to remain below the state average, they have seen a 15.8 percent wage increase since 2015. Wage growth, coupled with an increase in the number of establishments indicates that accommodation and food services is likely to continue to be one of the largest employing industries in Virginia.








Manufacturing




Manufacturing was the fifth highest industry by employment in the Commonwealth. Despite slow growth of only 0.4 percent in the past five years, employment in 2020 was 244,031, roughly 6.5 percent of total statewide employment. The manufacturing industry accounts for \$15.8 billion in wages, approximately 6.5 percent of total wages in the Commonwealth. The average weekly wage of \$1,247 per week was slightly under the statewide average of \$1,253 per week. The slow employment growth is largely due to average employment decreases in many of the sub-sectors. Two subsectors that saw employment decrease over the last five years were the machinery manufacturing and the printing and related support activities sub-sectors. Each sub-sector saw employment decreases by roughly 1,500 jobs. In spite of the small gains in employment, wages have seen steady growth since 2015. Leather and allied product manufacturing and food manufacturing were the sub-sectors with the highest wage growth, up 27.8 percent and 19.9 percent respectively since 2015.




